Describing a behavior is ______ the same as describing it.

Behavioral descriptions are:

- Necessary so you know what specific behavior is targeted for change
- Important to implement an intervention plan consistently
- Observable-they are written so that everyone can agree on whether the behavior is occurring
- Measurable- measuring behavior is the only way to know if the behavior plan is working. Must make decisions

Describing Behavior

There are 2 types of behaviors that behaviorists target for change.
1. Behavioral excesses: undesirable behaviors we want to decrease, such as aggression_____,
2. Behavioral deficits: desirable behaviors we want to increase: talking,_____,
______,

Behavioral definitions must be:

- Explicit: accurate, specific description of behavior to be changed
- Objective: behavior must be observable (not subjective or open to opinion)
- Clear: not confusing (avoid using words with multiple meanings)
- Complete: include what the behavior is and what it is not
- Agreement: after reading the definition, different people would agree if it occurred or not

In addition to defining the behavior, we need to define the environmental events surrounding the behavior: conditions under which the behavior is occurring that is the problem, not the actual behavior.

Be able to describe the physical events in the environment that reliably produce or precede the behavior as well as events that immediately follow the behavior. Specifying environmental events is important in scoring occurrence of behavior accurately.
